Executive Summary

Advances continue to be made at each development during the month of March. At BNA Nashville International in

Nashville, Tennessee, all remaining punch list items except for landscaping have been completed by the general

contractor, Dunn Building Company, At OPF Opa Locka in Miami, Florida, the general contractor, Link Construction

is nearly complete with their punch list and is on schedule to complete the tenant improvement project in hangar 5.

At APA Centennial in Denver, Colorado, permits for water and sewer have been received and installation of these

utilities by the general contractor, A&F General Contractors has begun. At DVT Deer Valley in Phoenix, Arizona,

the permit for the fuel farm has been received, and issuance of the project's building permit has been authorized

pending receipt of the permit fee. Rapid Built, the pre-engineered metal building (PEMB) provider for Sky Harbour,

has completed fabricating the steel superstructure for the metal buildings at DVT and will start deliveries in early

April.

The following is a summary of progress at each development.

Field: OPF Phase 1 - Opa Locka, Florida

Reporting Period: March 2023

1. Construction Status:

Link Construction (the general contractor) completed their punch list items by installing sod along the east

side of the apron at hangar 12 and correcting several issues within the airside retention areas. The interior

buildout of hangar 5 continues and is on schedule for completion at the end of April. The drywall has been

finished, MEP rough-in completed, and the metal pan stairs and decorative stairs have both been installed.

The glass is currently being installed, and the epoxy flooring is scheduled for the first week of April.

Field: OPF Phase 2 – Opa Locka, Florida

Reporting Period: March 2023

1. Design & Permitting Status:

The site plan and unit mix for phase 2 has been finalized. The program now meets the market demand for larger hangars and includes two (2)-SH30s and three (3)-SH16s. Proposals from the Civil Engineer and the Architect for the project redesign have been received by Sky Harbour and are presently being negotiated. The design team will be released in April with an aggressive 2-3 month redesign schedule while Sky Harbour continues to pursue relief from the Miami Dade Fire requirement for foam in the development. Until this decision by Miami-Dade County Fire Department is made, we will not be able to finalize the design as multiple trades will be impacted.

2. Schedule Variances:

Given the late April start date, a 2-3 month redesign duration, and a 3-4 month timeframe for the county and airport review / approvals process, the start of construction will shift to the 4th quarter of 2023.





Field: APA – Englewood, Colorado **Reporting Period**: March 2023

1. Design and Permitting Status:

The Arapahoe County Water & Wastewater Authority (ACWWA) permit has been issued and the water and sewer utility installation is underway. Southeast Metro Stormwater Authority (SEMSWA) released their final agreements for the SEMSWA permit to be issued, pending receipt of a letter of credit for the value of the work from Sky Harbour. Once the letter of credit is in place, the SEMSWA permit will be issued – this is anticipated in mid-April. Once the SEMSWA permit is issued, Arapahoe County Building Department will finalize their review and issue permits for the buildings (to be issued within one week of SEMSWA permit issuance). Sky Harbour will need to submit the deferred submittal drawings for the permit associated with the Pre-Engineered Metal Building (PEMB), which is required by the Arapahoe County Building Department. Niles Bolton Architects is finalizing the showroom hangar finish plans for issuance to team. The revised plan set which includes the model hangar drawings will be issued mid-April.

2. Construction Status:

The General Contractor (A&F General Contractors) is currently installing the water and sewer utilities. After the SEMSWA permit is received in April, the utility connections within Isbill Road will be constructed and tied into the development. Once the Arapahoe building permit is received, work on the building foundations can begin.



1. Design and Permitting Status:

PDD has given final approval for the project's building permit and determined the permit fee amount. Once

the check for the permit fees is received by PDD, the building permit will be issued. The project's fuel farm

permit was issued in March, and the team is currently coordinating the commencement of sitework with the

City of Phoenix's Aviation Department. The revised foundation plans for the Pre-Engineered Metal Building

(PEMB) were also submitted in March, and approval is expected by the end of April.

2. Construction Status:

The general contractor (Haydon) commenced underground plumbing rough-in for hangars A, B, C, D, E, F

and the GSE building. Underground plumbing rough-in for hangars G & H remain pending completion of

new storm water drainage piping to re-route existing storm drainage on site. Concrete foundation

excavation has begun, and the first pour for Hangar A has been completed.




