This presentation includes the following non-GAAP performance measures: net revenue (and by calculation, net revenue yield on AUM), adjusted operating expenses, adjusted operating income, adjusted operating margin, adjusted net income attributable to Invesco Ltd., and adjusted diluted earnings per share (EPS). We believe the adjusted measures provide valuable insight into our ongoing operational performance and assist in comparisons to our competitors. These measures also assist management with the establishment of operational budgets and forecasts. The most directly comparable U.S. GAAP measures are operating revenues (and by calculation, gross revenue yield on AUM), operating expenses, operating income, operating margin, net income attributable to Invesco Ltd., and diluted EPS. A reconciliation of U.S. GAAP results to non-GAAP results may be found in the Appendix.

The information in this presentation is meant to supplement the information contained in the earnings release and includes a more detailed reconciliation format of the income statement from U.S. GAAP to a non-GAAP presentation. We believe that this presentation is useful, as it aggregates the various non-GAAP adjustments to illustrate adjusted revenue and expense categories and allows more transparency into the calculation of the non-GAAP financial measures.

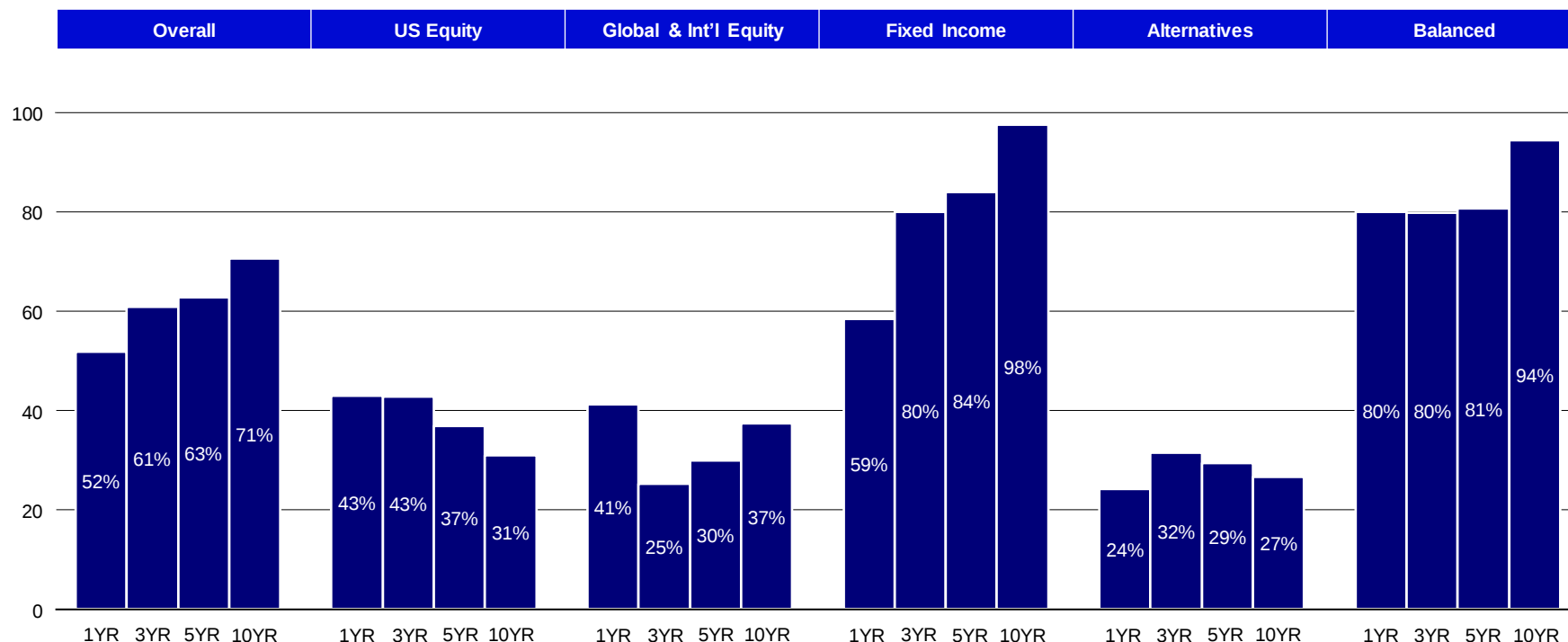

- Growth in key capabilities offsetting redemptions in challenging industry climate, net flows performance in upper echelon of asset managers
 - ETF net long-term inflows were +\$4.3 billion in fourth quarter (7% organic growth rate)
 - Fixed Income strategies and the Institutional channel extended streak of consecutive net inflow quarters (16th and 13th respectively)
 - Net long-term flows break-even for FY 2022, as strong growth in key capabilities offset industry-wide redemptions pressure
- Balance sheet strength – total debt of \$1.5 billion is at lowest level in 10 years, credit facility balance of \$0 and cash and cash equivalents balance over \$1.2 billion
- Continued focus on expense discipline, re-allocating resources to growth areas and positioning the firm for positive operating leverage as markets recover

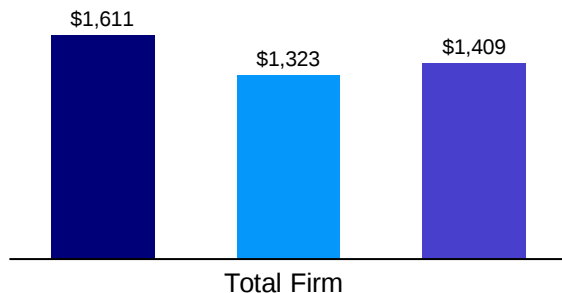

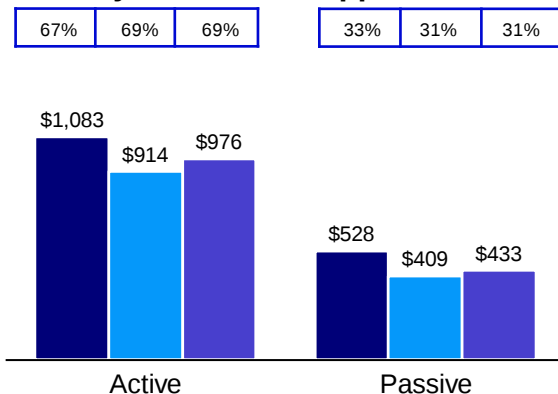

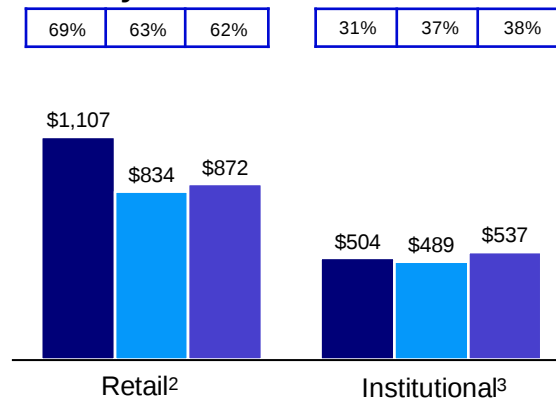

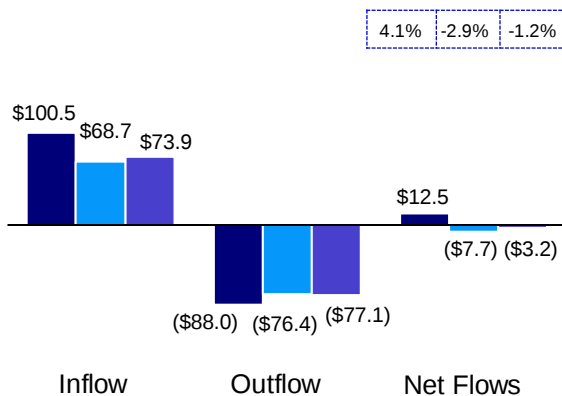
AUM by Investment Approach



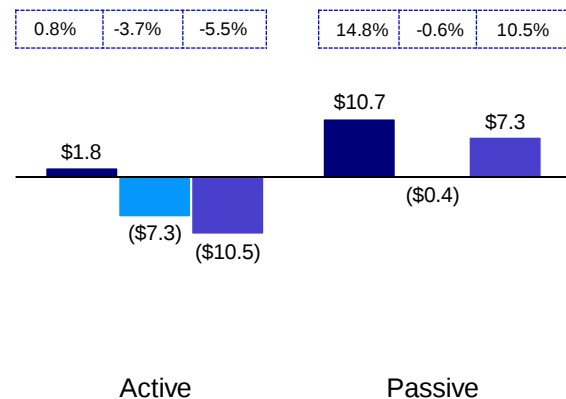
AUM by Channel



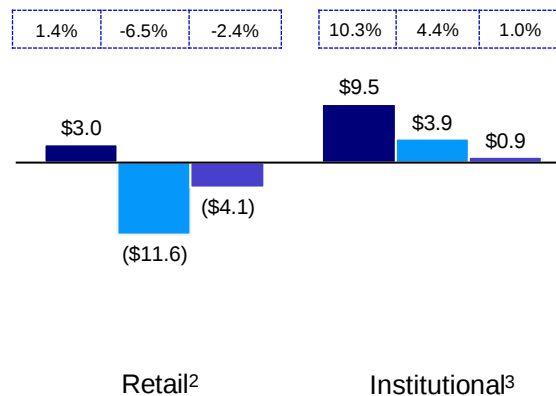
Long-Term Flows

Net Long-Term Flows by Channel



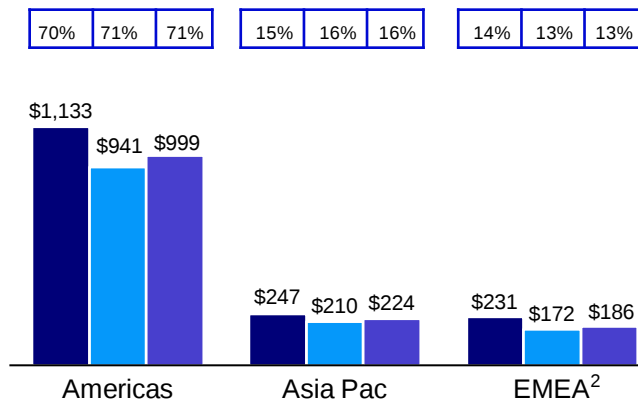

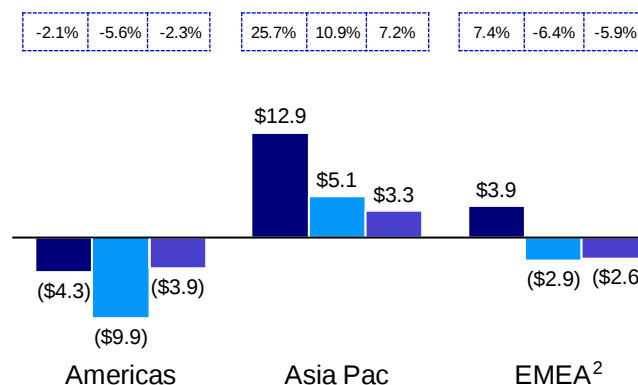

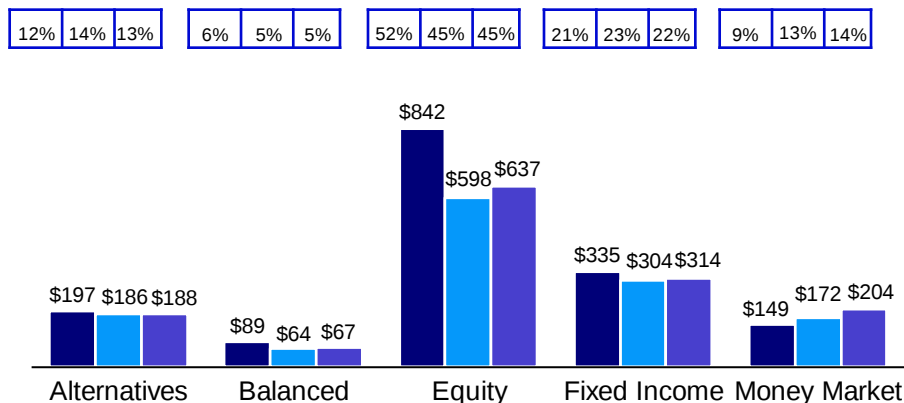
AUM by Geography



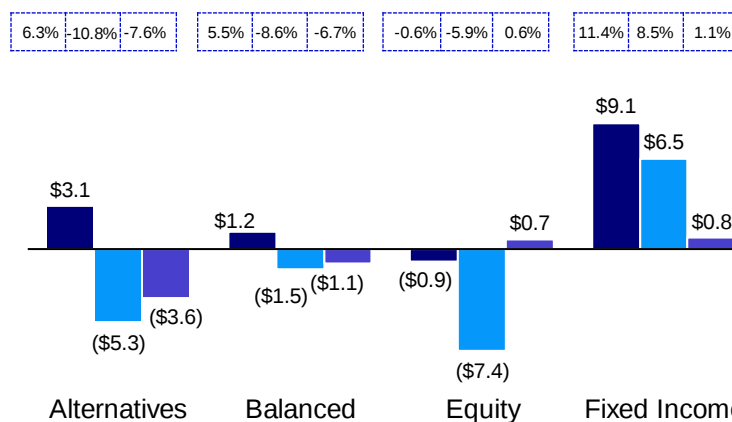
Net Long-Term Flows by Geography

Net Long-Term Flows by Asset Class

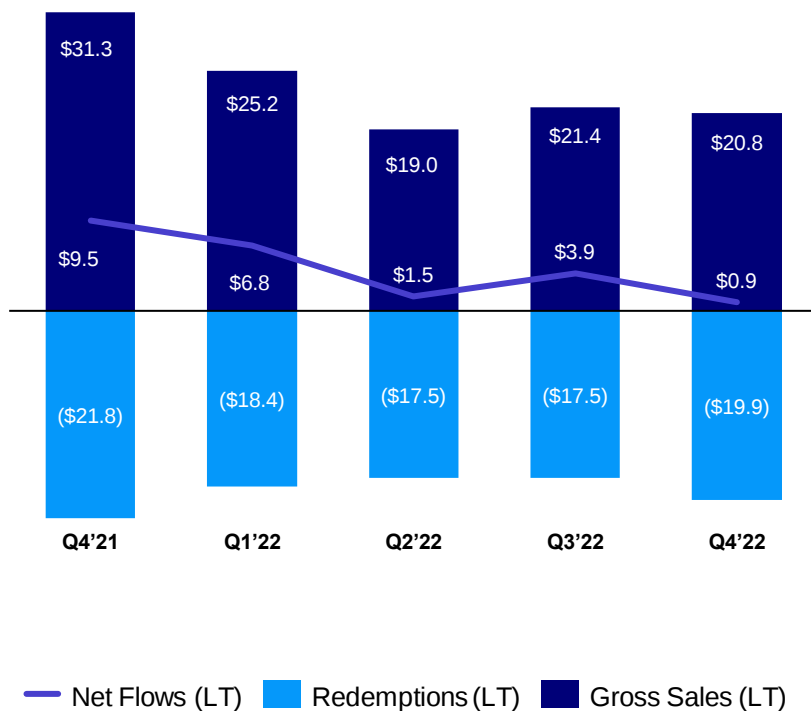

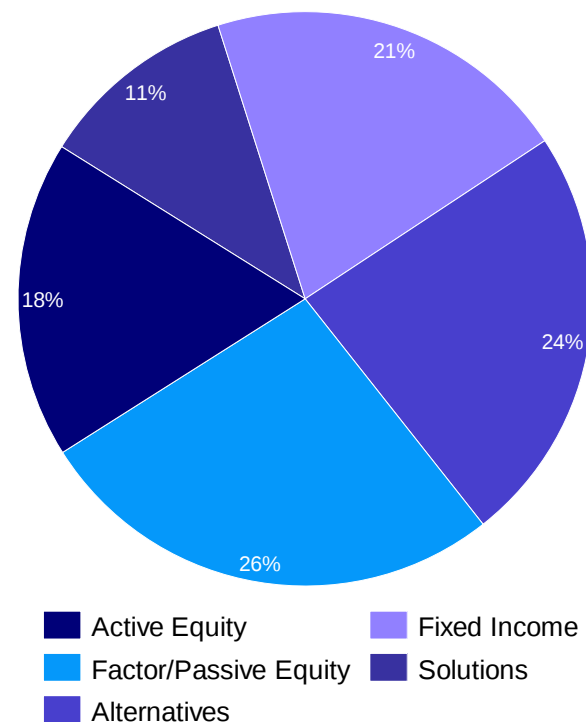
Global Institutional LT Flows

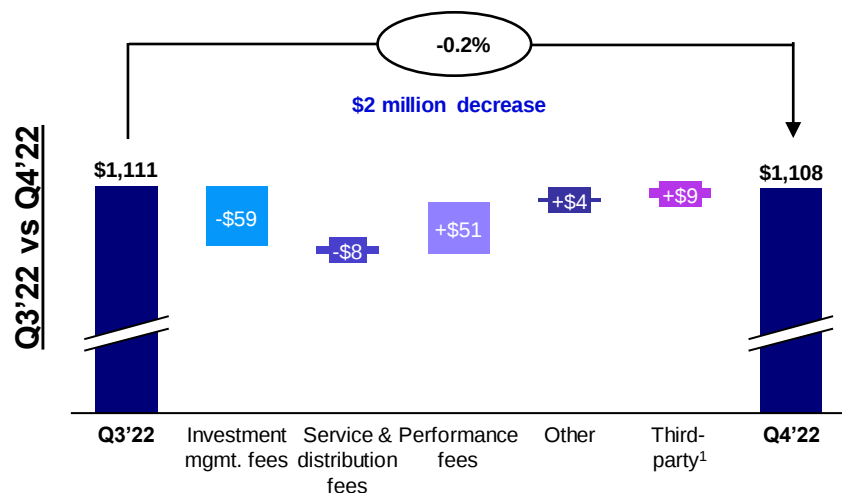
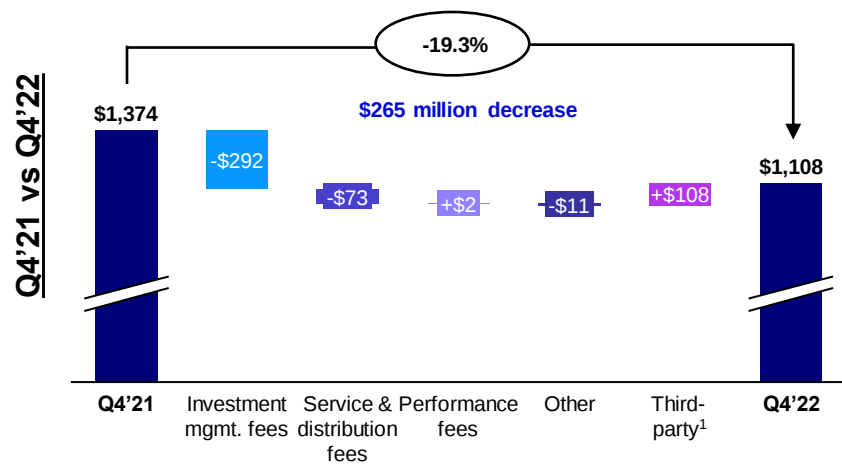

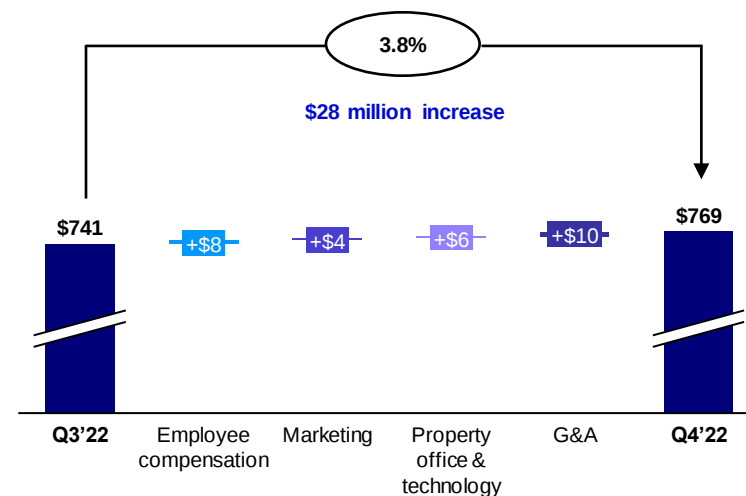
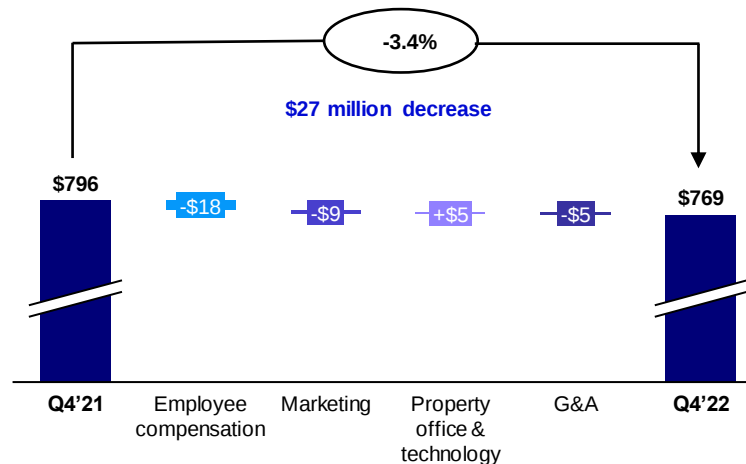

Adjusted Operating Expenses

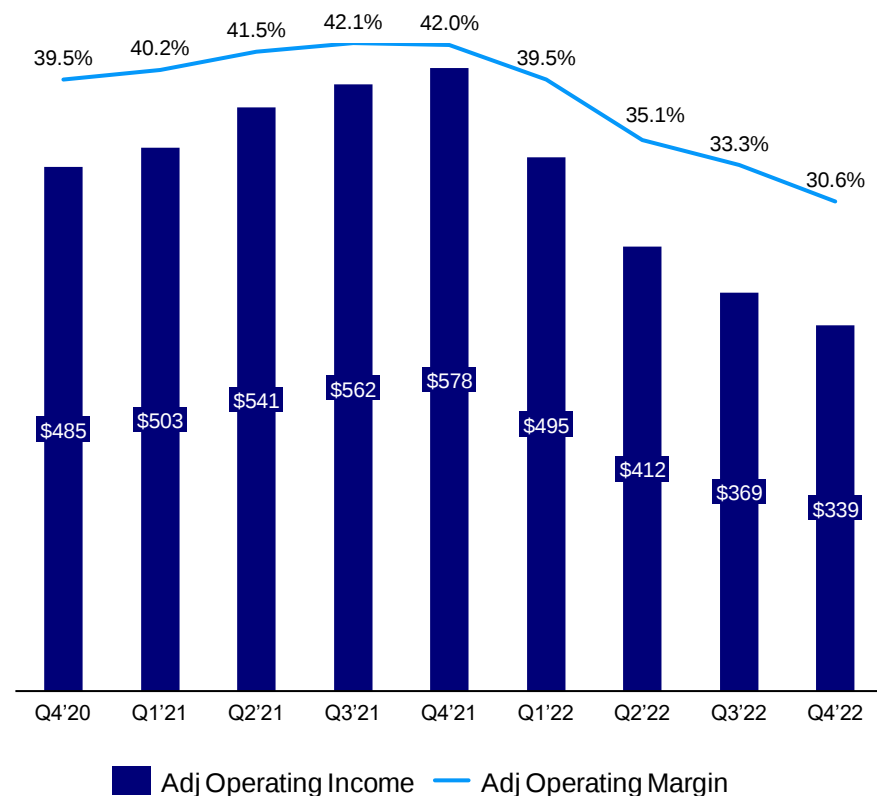

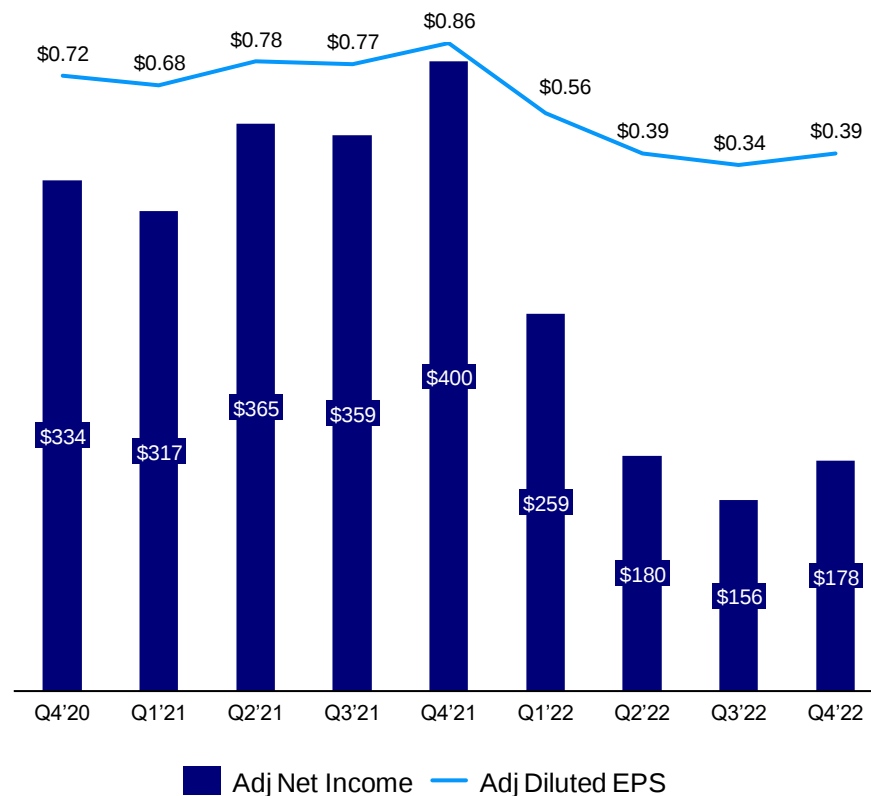
Adjusted operating income and profitability

Adjusted Net Income and Adjusted Diluted Earnings Per Share

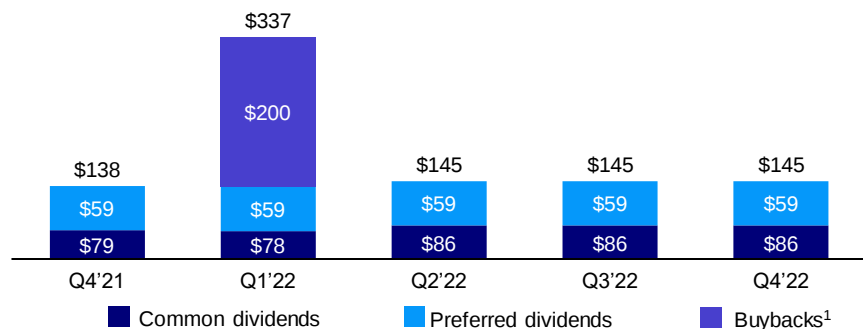

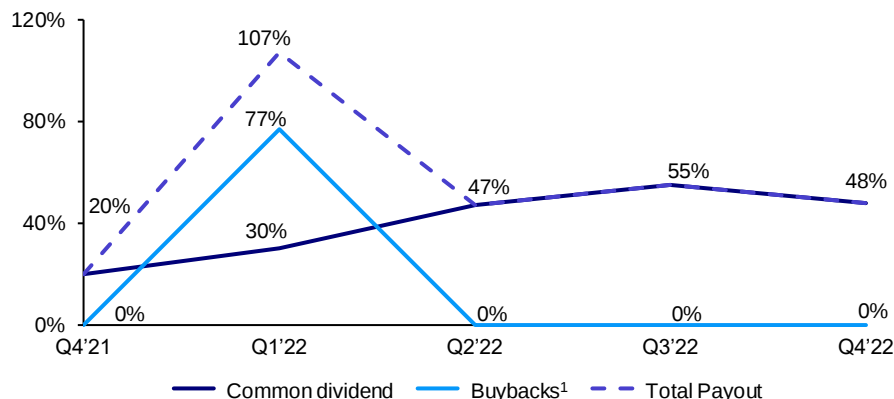

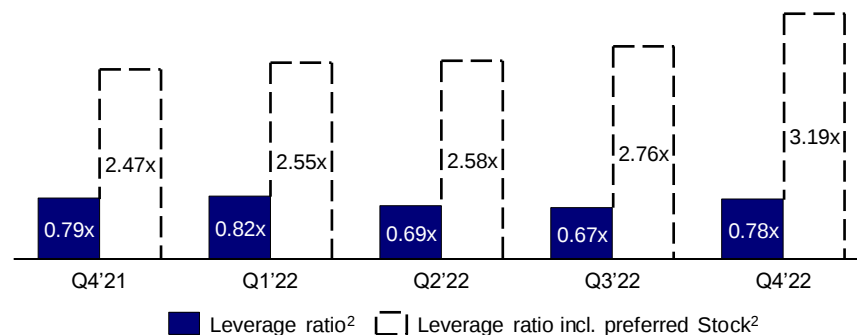
Capital Returned to Shareholders



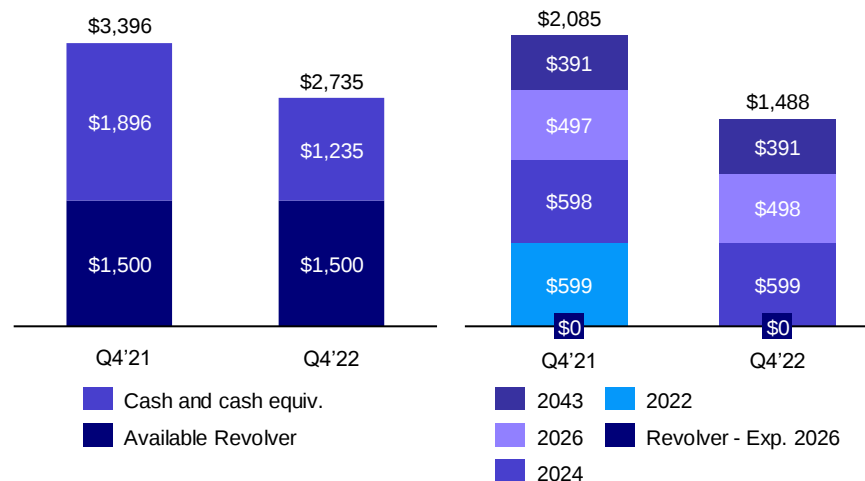
Common Shareholders Payout Ratio, as % of Adj. Net Income*

Conclusion

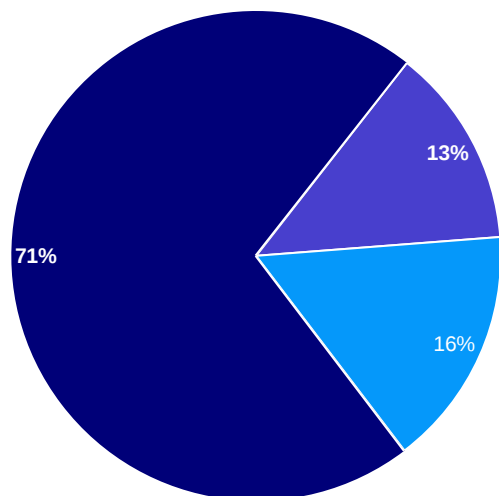
- **Differentiated capabilities in areas of high client demand continue to grow despite challenging environment**
 - Global ETFs delivered 7% organic growth in fourth quarter and 11% for FY 2022
 - Fixed Income Strategies and Global Institutional Channel extended streaks of consecutive net inflow quarters (16th and 13th respectively, with +\$0.8 billion and +\$0.9 billion each in 4th quarter)
 - Firm achieved break-even net LT flows for FY 2022, despite the most challenging equity and bond markets in decades
- **Continued focus on expense discipline, investment in growth, and positioning the firm to deliver positive operating leverage as AUM recovers**
 - Adjusted operating margin* of 30.6%, impacted by challenging market and industry backdrop
 - Re-allocating resources to key growth areas: ETFs, Active Fixed Income, Greater China, Solutions, Private Markets and Active Global Equities
 - Investing in foundational technology projects that will benefit future scale
- **Balance sheet strength has Invesco well positioned for the future**
 - Debt remains at lowest level in 10 years (\$1.5 billion, \$0 credit facility balance)
 - Cash and cash equivalents balance increased to over \$1.2 billion

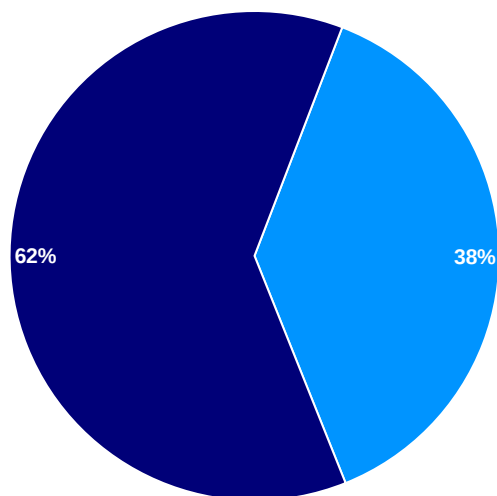

By Client Domicile



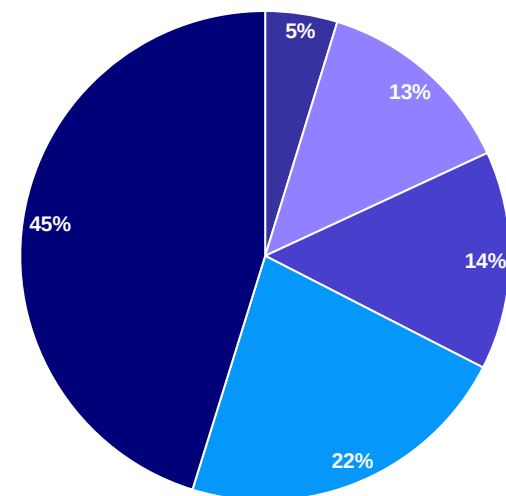

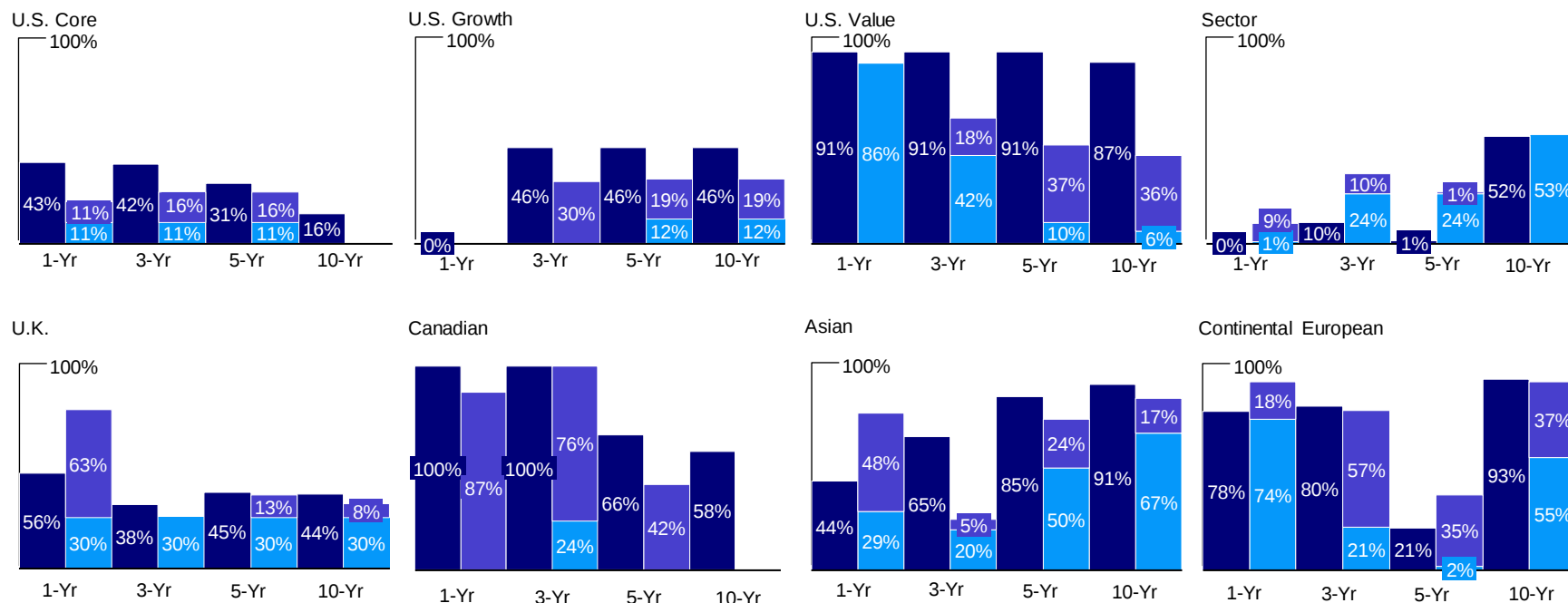

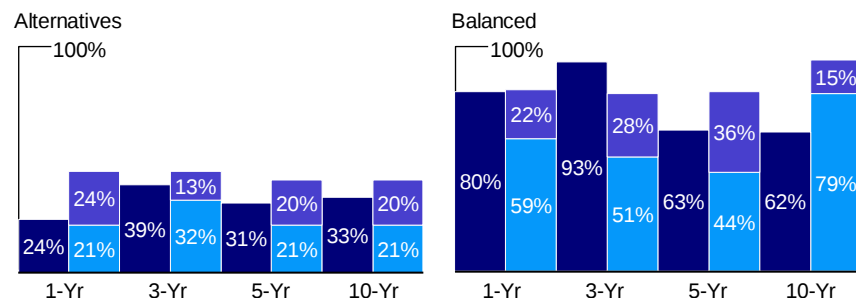
By investment objective (actively managed assets)*

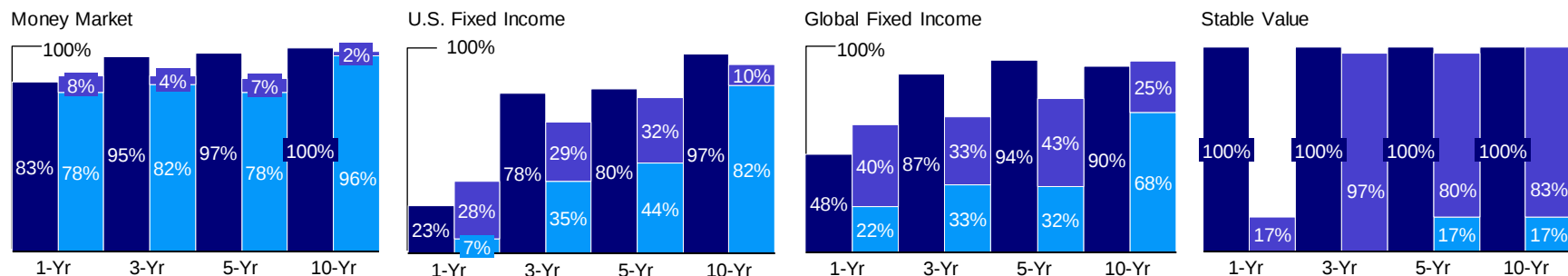

Leverage ratio including preferred stock is adjusted debt, as defined in the credit agreement, plus the preferred stock balance of \$4,010.5 million (for all periods presented), divided by EBITDA

The calculation of adjusted debt is defined in our credit facility and equals debt plus letters of credit less excess unrestricted cash (cash and cash equivalents less the minimum regulatory capital requirement), not to exceed \$200 million. For Q4 2022, adjusted debt of \$1,290.3 million is calculated as debt of \$1,487.6 million plus \$2.7 million in letters of credit less \$200.0 million of excess unrestricted cash.
