Frontier Oil Declares Cash Dividend

HOUSTON, Sept 14, 2006 /PRNewswire-FirstCall via COMTEX News Network/ -- The Board of Directors of Frontier Oil Corporation (NYSE: FTO) declared a regular quarterly cash dividend on the Company's common stock of \$0.03 per share (\$0.12 annualized). The dividend is payable October 11, 2006 to shareholders of record on September 29, 2006.

Frontier operates a 110,000 barrel-per-day refinery located in El Dorado, Kansas, and a 52,000 barrel-per-day refinery located in Cheyenne, Wyoming, and markets its refined products principally along the eastern slope of the Rocky Mountains and in other neighboring plains states.
