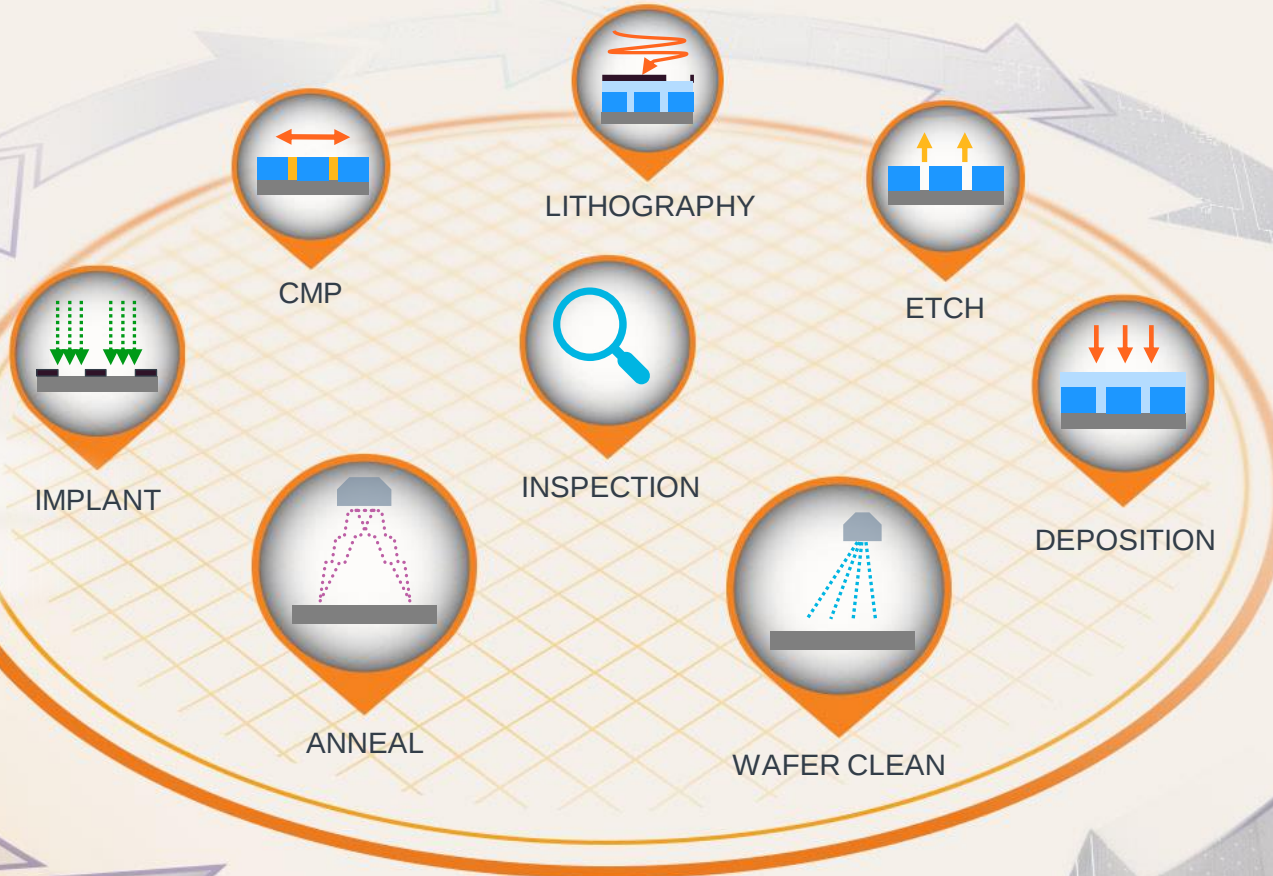

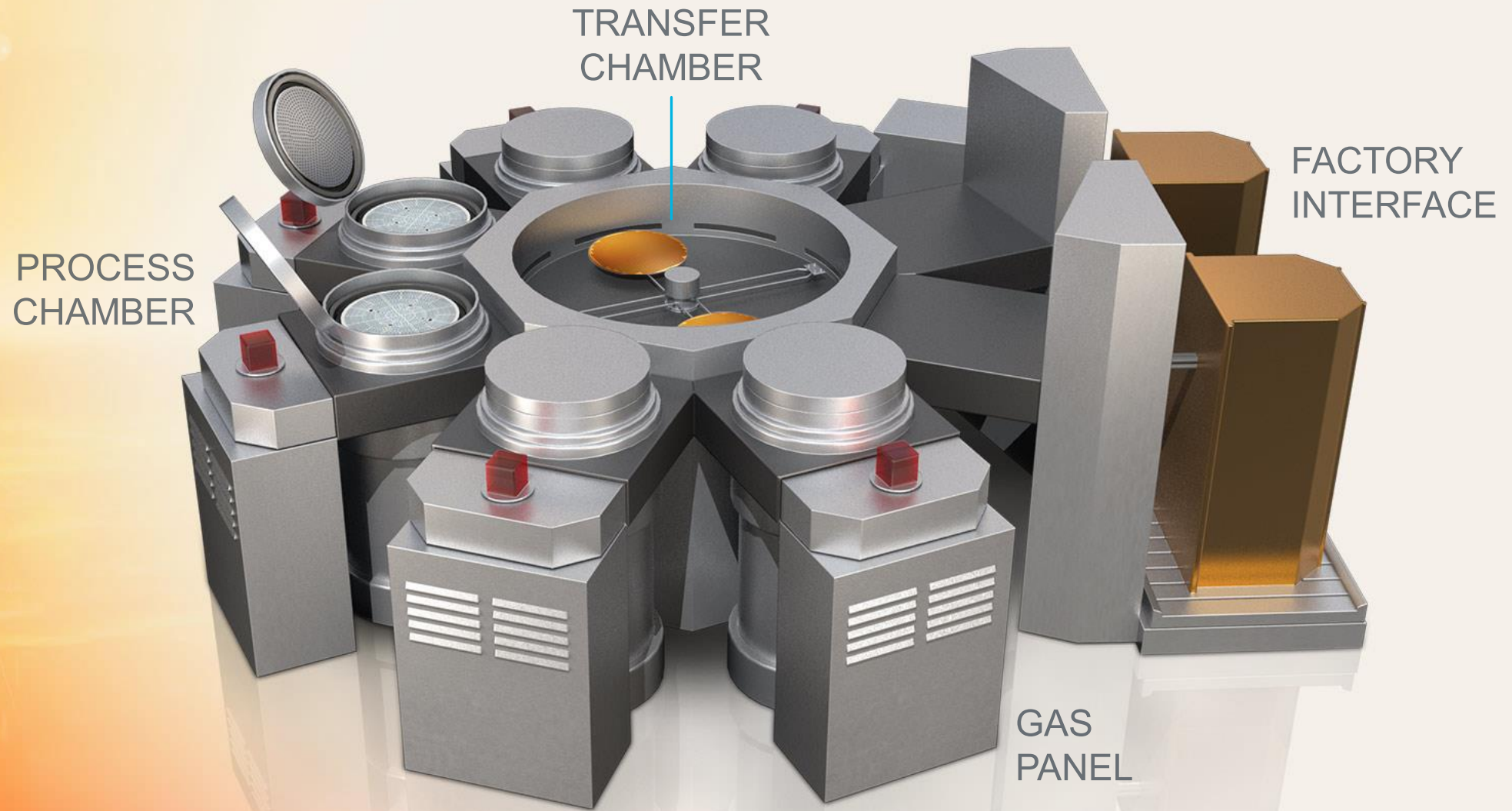

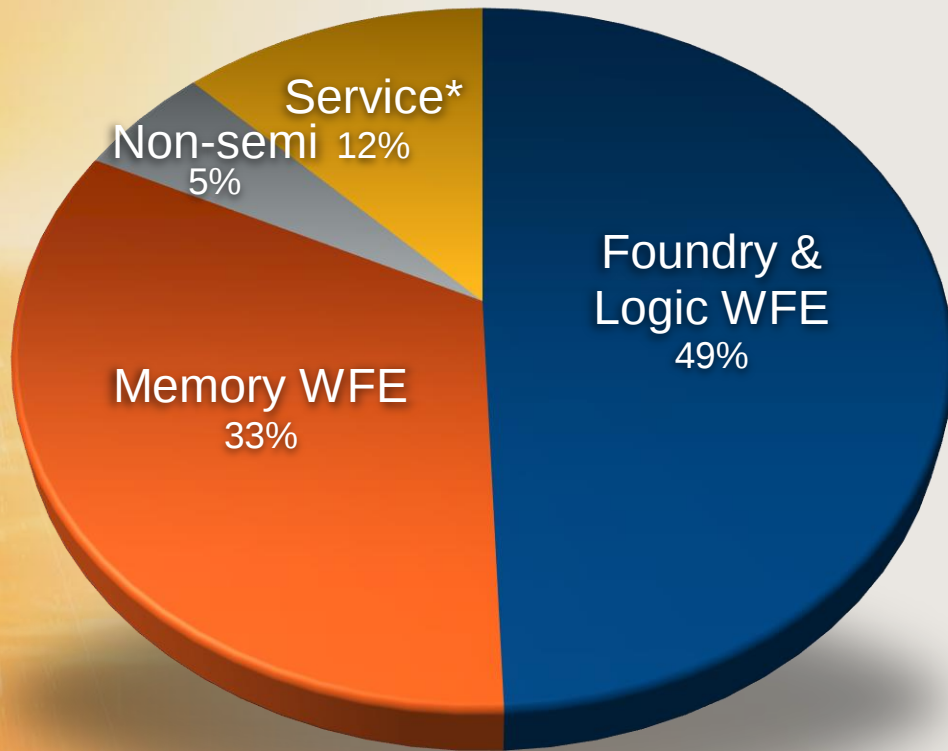

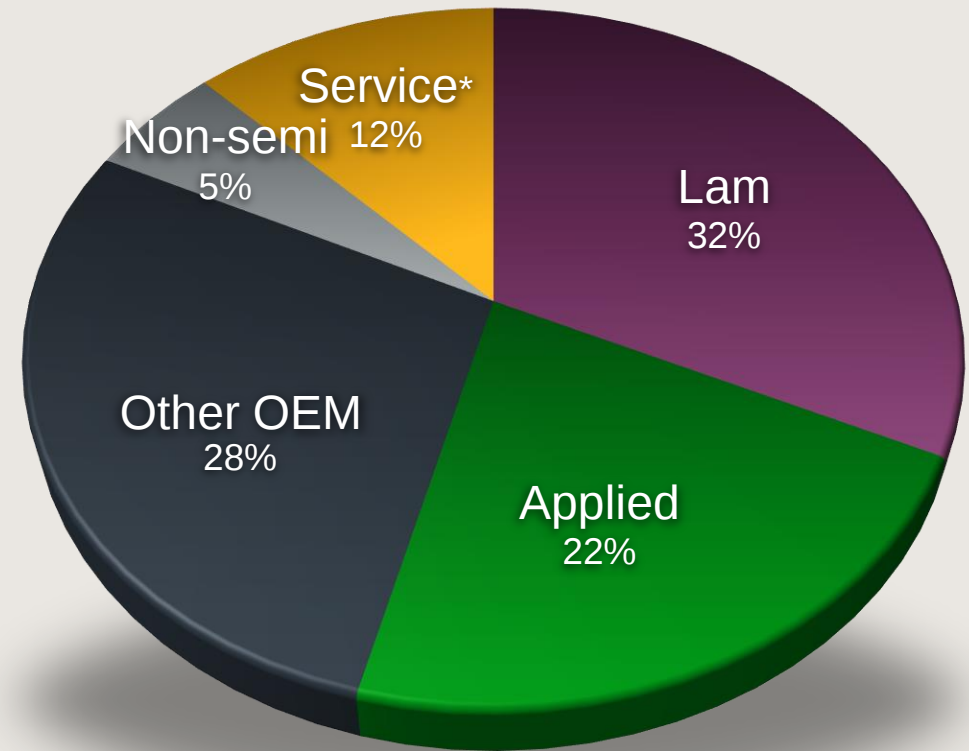


Industry and Customer Footprint (Q2'24)

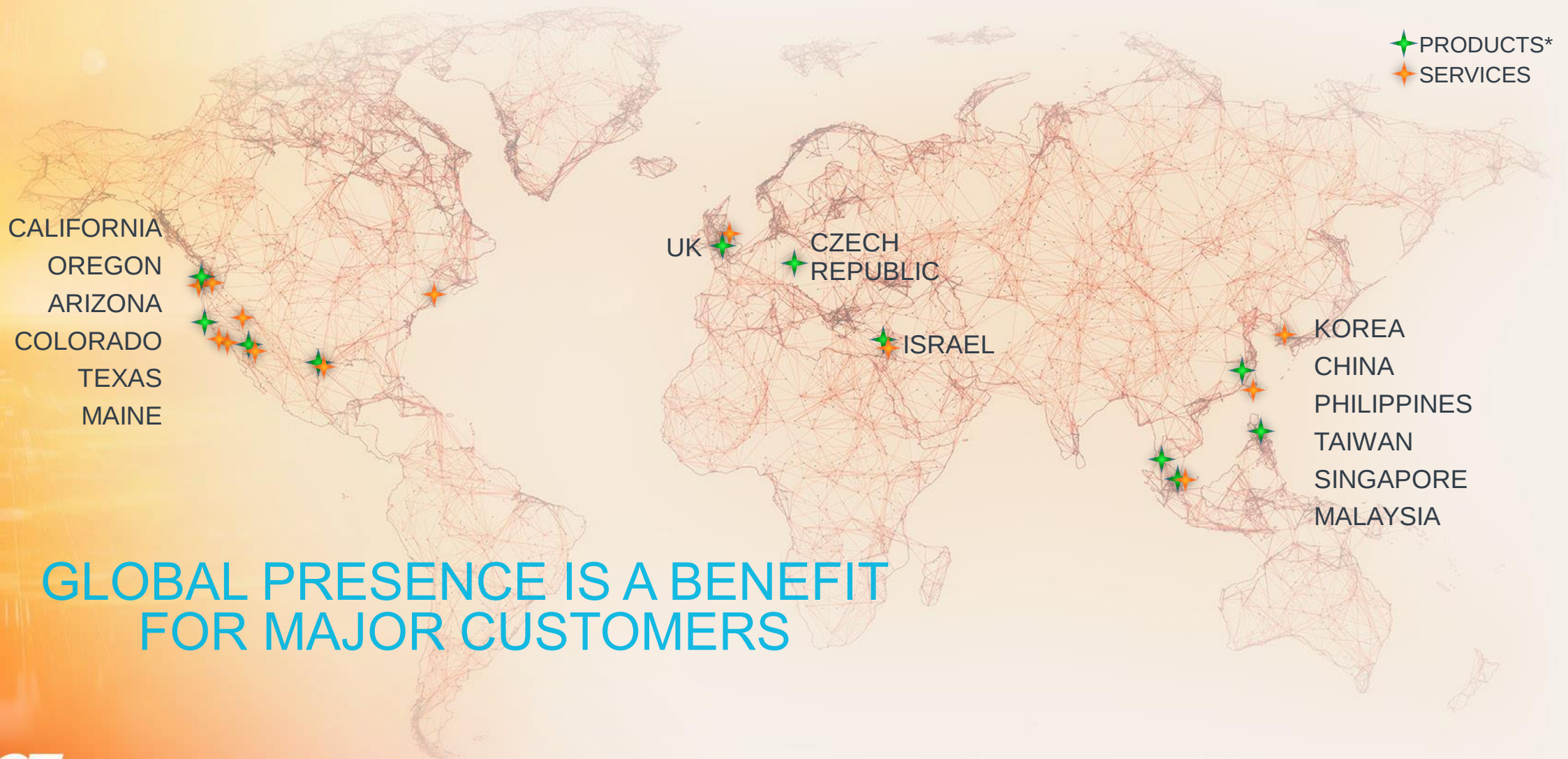
UCT REVENUE BY SEGMENT

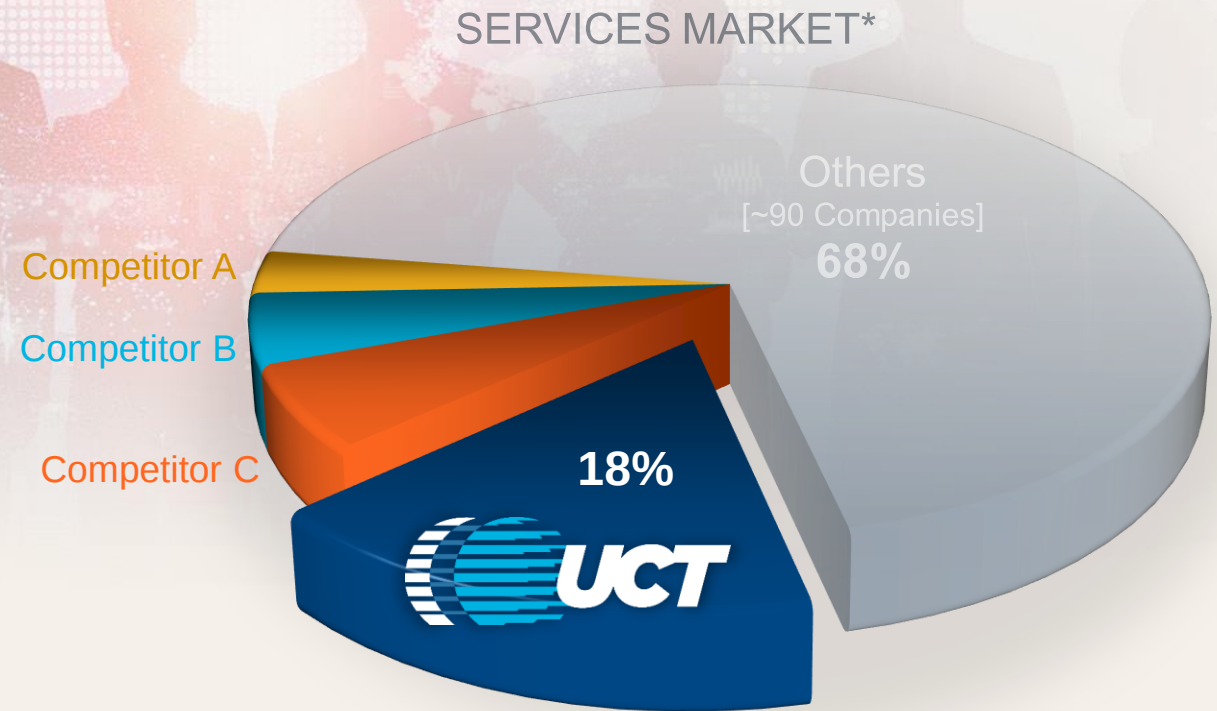

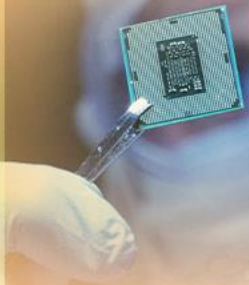
