### **American Homes 4 Rent Announces Distributions**

AGOURA HILLS, Calif., February 25, 2016—American Homes 4 Rent (NYSE: AMH) (the “Company”), a leading provider of high quality single-family homes for rent, today announced that, on February 25, 2016, the Board of Trustees declared a dividend of \$0.05 per share on the Company’s common shares for the first quarter of 2016. The distribution will be payable in cash on March 31, 2016, to shareholders of record on March 15, 2016.

The Board of Trustees also declared a per share quarterly distribution on the Company’s participating preferred shares of \$0.3125 on the 5.000% Series A shares, \$0.3125 on the 5.000% Series B shares and \$0.34375 on the 5.5000% Series C shares, payable on March 31, 2016, to shareholders of record on March 15, 2016.
