(b) The board of directors may, without authorization of the shareholders, from time to time, in such amounts and on such terms as it deems expedient: (i) borrow money on the behalf of the Corporation; (ii) issue, re-issue, sell or pledge debt obligations of the Corporation; or (iii) charge, mortgage, hypothecate, pledge or otherwise create a security interest in all or any currently owned or subsequently acquired real or personal, moveable or immovable property of the Corporation, including book debts, rights, powers, franchises and undertaking, to secure any debt obligation or any money borrowed or any other debt or liability of the Corporation. For greater certainty the forgoing powers conferred on the directors shall be deemed to include the powers conferred on a company by Division VII of the Special Corporate Powers Act, being Chapter P-16 of the Revised Statutes of Quebec, 1977 and every provision that may be substituted therefore or for any provision therein. The board of directors may from time to time delegate to such one or more of the directors or officers of the Corporation as may be designated by the board all or any of the powers conferred on the board by the provisions of the foregoing paragraphs to such extent and such manner as the board shall determine at the time of such delegation.
